Hi Shawn,

Perhaps we can jump on quick call tomorrow morning, because I want to make sure I understand your client's comments below. Adding a line for the members to identify

their TPN shouldn't be an issue, though it is really necessary either, since that's so readily accessible on existing member rolls. It's no different than any other shareholder vote, where each shareholder votes per share they own, but they don't have to individually list each share them have, if that makes sense. And I am a bit concerned that some members might have difficulty looking up their TPNs or writing them correctly on their forms. And since that TPN information isn't necessary for us to accurately count proxies, I'd hate to potentially invalidate proxies on a needless basis. We should discuss this one.

With respect to the other issues, I think believe the instructions in the Proxy Card actually addresses those concerns. I think it'd be faster to work through on a call. I'm available in the morning, but tied up the rest of the afternoon tomorrow.

This proposed form is missing things that EWUA has required in the past such as the TPN and Account number and that are essential to making the inspector's job relatively easy. It does not include any information about where to send the form.

This form duplicates the flaw of the 2023 director ballot. There is nothing other than the member's name to identify which membership is casting the vote. This would require the inspector to spend considerable time trying to figure out which TPNs the signer is casting votes on behalf of, votes should be by membership not by member.

Only the name of the designated proxy holder should be kept from Section I. The other elements should be deleted.

Hi Shawn,

Thanks for the call earlier today. Attached is a *rough* draft form proxy card. Obviously, there's some additional information to fill in, but let me know what you think in terms of substance. Per the bylaws, the Board would need to approve a final form of this, but I'm hopeful that they can agree to something substantively like this, which is pretty neutral and standard. A copy of this Proxy Form would go out with the Notice of Special Meeting, which I think should be emailed and mailed to all members. The Notice of Meeting should include:

- The basic information regarding the meeting logistics: date, time, place, and a reminder that all members need to bring their ID with them if they attend the meeting
 – the meeting itself needs to be set within 35 days of the Notice of Meeting going out, but we would still want to set it out far enough that we give sufficient time so that people can get their proxies in
- A description of the purpose of the meeting: to vote on the two recall petitions
- 3. One statement from each camp: one from the majority and one from the minority, summarizing their respective positions
- 4. Plain language instruction about the proxy cards, and encouraging people

to vote by proxy so as to streamline how many votes we need to count during the meeting.

For day of the Special Meeting itself, we would have a spreadsheet of all members ready to go, with columns so that we can check everyone in, check IDs, and confirm proxy cards (if people bring them with them to the meeting). And at the top of the meeting, we would announce the basic agreed upon parameters, something like: each side gets 20-30 of allotted time to present their case and another allotted amount of time for member questions. And then we take the vote.
