- 1. EWUA's cannot just become a public taxing water district. State law allows only one district to exist and Eastsound already has one, Eastsound Sewer and Water District.
- 2. Jim Cook commented that Steve Smith is in full support of the recall and he is helping the minority through the recall process.
- 3. Teri Nigretto stated that the current Bylaws were created by Steve Smith and some of it is not in compliance with state law. The current board started working on revising them in February and had to pause the process in March to be continued as soon as possible.
